



GENERAL REGULATIONS

Article 1 Participants

Intesa Neoartgallery cultural union has established EuroExpoArt (EEA) together with Romagna Fiere. Participants from all ages, nationalities can participate with any techniques, style or size. All artists can exhibit more than one work and they can present their works with different artistic expressions. The images of these works should be sent in jpeg format, in accordance with printing quality, and they should describe the title, the sizes and the production year.

Article 2 Subject - Style

EEA accepts all subjects and works including basic artistic expressions in a way that does not attack political, religious, moral values or disturb people. All Visual Art works shall be included: sculpture, painting, photography, digital art, graphical works created using all techniques.

Article 3 To Participate

To participate to EEA, the legislation shall be read carefully and on official participation application shall be realized as described in the attachments or the following e-mail shall be sent to euroexpoart@gmail.com :

Article 4 Competition Rating

With the form filled by the visitors of the art fair named "Vernice" in EEA, which works are favoured more shall be determined and these works shall be taken in the competition rating. First 30 works shall be evaluated and awarded by the jury directed by Romagna Fuarciılık President.

Article 5 Awards

The artists which have works that are favoured the most in the competition rating shall be included in the following award categories:

- **GOLD** - Stand in Vernice art fair
- **SILVER** - Advertisement / article in art magazine
- **BRONZE** - Catalogue

Article 6 Submitting the works and retrieving them

Artists shall send their works to the following address of the event center:

The deliveries from aboard shall be arranged as round trip.

Returns shall be made between the third and fifteenth day after the end of the event.

Works should be delivered 10 days before the opening of the event. At the end of the event, the works to be returned, shall be packaged properly and put in reusable boxes so that they will not be damaged and/or cost extra and they are in accordance with the rules, there shall be two copies of a letter which includes the information of the return address and photograph of the work and name and surname of the address in the package and the box. All packaged materials shall be charged to the artist and the artist's name shall be specified.

Deliveries by hand shall be accepted until 2 days before the opening date.

Receipts by hand shall be accepted immediately at the end of the event.

Article 7 Emancipation

Organizers shall take care of the works they receive with the utmost attention and they shall not be held responsible due to the damages arising during the transportation, waiting stage before/after the event, damages such as theft, fire, breakdown.

Organizers are not responsible for transportation and customs, operation and costs.

Article 8 Acceptance of the Conditions

Artists guarantee that the works presented by them at Artists EuroExpoArt International Community are in accordance with the event rules and they are original.

Artists who sign and deliver the Neoartgallery Union legislation specified attachments are deemed to have read, understood and accepted the articles.

ATTACHMENTS

1)

Together with the high quality photograph of the work suitable to print in jpeg format. The name (title), technique, dimensions and production year information of the work shall be sent to the euroexpoart@gmail.com e-mail address, the related photograph and the information shall be used on the catalogue of the event and on the other advertisement areas.

2)

- For pictures up to 80 cm, 150 Euro participation fee is collected from the artist.
- The contribution fee for works between 80 cm and 180 cm is 250 Euro (*).
- 150 Euro participation fee is collected from the artist for sculptures with the sizes of 50x50 cm and 100 cm height (*).

() It is possible to participate with bigger works to the event, the related contribution fee shall be determined after meeting with union directors.*

- 150 Euro contribution fee is collected from the artists for video uploads, projection device costs are not included in this contribution fee.

3)

A copy of the catalogue of the WORKS presented and the event shall be delivered to each artist during the Fair. In exchange for 15 Euro fee, and prior notification, it is possible to receive more catalogues.

4)

- All contribution fee payments shall be transferred to Romagna Fuarçılık bank account number or by making the demand, it may be paid through PayPal.
- Any charging concerning the payment, shall be paid by the artist. Payment through PayPal will require a 10 euros use charge. The cost of bank transfer will depend on the artists bank.
- During the payment stage, the artist shall state his/her name and surname to EEA.
- A COPY OF THE PAYMENT RECEIPT SHALL BE SENT TO euroexpoart@gmail.com EMAIL ADDRESS AS SOON AS THE PAYMENT IS MADE.
