

**EUROEXPOART REGULATION**  
**Vernice Art Fair Forli**

**Art. 1 Participants**

The Neoartgallery cultural association in cooperation together with Romagna Fiere establishes EuroExpoArt, hereinafter EEA. Artists of any nationality, without age limits, working with any technique and style, using the foreseen dimension, can participate in EEA. Each artist can exhibit several works, even of different artistic expressions, indicating the work in evidence of which he can present a high quality jpg image suitable for printing.

**Art. 2 Theme - Styles**

The EEA Theme is free. The non-offensive artistic action of political, religious, moral sensitivities and feelings suitable for peaceful coexistence is considered a fundamental element. All variants of the Visual Arts are allowed: sculpture, painting, photography, digital art, graphics, etc ...

**Art. 3 How to register**

To participate in EEA it is necessary to carefully read these regulations and sign it in the appropriate spaces. The copy must be sent to: [info@neoartgallery.it](mailto:info@neoartgallery.it)

**Art. 4 Delivery and collection of the works**

Artists must send the works to the office of the association at the following address:

The works must be received 10 days before the inauguration. In order to avoid damage and / or additional costs for returning the works, they must be packaged in a workmanlike manner with reusable box or crate. Inside the crate or box an envelope with 2 copies of the address must be inserted for the return shipping. All the packaging material must be branded with the artist's name. Hand deliveries must be made the day before the inauguration. Pick up by hand must be done at the closing time of the event. It is understood that the artist have to afford the costs of the outward and / or return shipment as well as any costs of customs clearance.

**Art. 5 Disclaimer**

L'association, the organizers and the Curators, while adopting the maximum caution in exposing, storing and managing the works, cannot be held responsible for damages, shortages, deletions, thefts, tampering, fire, transport, etc, during the period of the event, of the storage, exhibition and stock. The association, the organizers and the Curators, do not have any liability connected with the transport, packaging and customs clearance. The work is exposed under the exclusive responsibility of the artist in any case. The possible insurance will be paid by the Artist. In order to the catalog the Artist exempts Neoartgallery association, the organizers and the Curators, from the responsibility for printing errors or typos.

**Art. 6 Acceptance of the conditions**

The artists are guaranteed with the originality of the work they present and, by participating at EEA, they accept all the rules contained in this announcement, none excluded. Through the subscription of the application form, the Artist becomes a temporary partner of the Neoartgallery association, declaring to have read carefully this regulation made up of 10 articles and accepting it in all its parts. We will send by email the association regulation.

**Art. 7 Image for the catalog**

The photo of the work, in jpg format, with a quality suitable for printing, has to be sent to [info@neoartgallery.it](mailto:info@neoartgallery.it).

The artist grants the widest faculty to use the image of his own work, sent in the manner described above, for the catalogue and for all useful uses for promoting the event, internationally and on a timed basis undetermined.

**Art. 8 Expenses and Contributions**

- Each artist will personally provide economic coverage of the services necessary for the realization

of the event, such as (but not limited to): participation in the competition, lighting, storage, entrance and parking pass, set-up, dismantling, collection of shipments, preparation of return shipping, press office, invitations, video services, catalog, museum's services, etc. for an amount of euro 200 related to the first meter of wall (the walls have 1 meter of length and 3 meters of height) or for the first sculpture.

**Art. 9 Catalog - Jury - Awards**

The printed color catalog, with the publication of the work indicated by each Artist, will be on sale on Amazon. The purchase link will be provided. The jury, chaired by the Honorary President of Romagna Fiere, will award prizes. The prizes foreseen for the winners of the competition are: 1st Category GOLD - 2nd Category SILVER - 3rd Category BRONZE. The winners will be recognized with certificates and exhibition's spaces.

**Art. 10 Privacy**
